
Interested in a Parcel?

Their diligent efforts have helped prevent these properties from contributing to blight in our community. We are incredibly grateful for the hard work and dedication of our contractors!

Blight Elimination

In 2023, the City of Kalamazoo was awarded the State Land Bank Authority Round 1 Blight Elimination funds. With these funds, the City of Kalamazoo elected to demolish 328 E Stockbridge, formerly known as the Bingo Hall.






Progress by the Numbers

In 2023, over 250 properties were managed in our inventory. Within those properties, there were 237 Residential Vacant, 27 Residential Structures, 20 Commercial Vacant, 2 Commercial Structures, 8 Industrial Vacant, and 1 Industrial Structures. The Land Bank acquired two parcels through tax foreclosure process in 2023, and completed 3 Fair Market sales, 3 Side Lot sales, 13 Nonprofit sales, and 1 Local Governance sales. For 2022, there were 39 tax foreclosures.

Eastside Square

The Eastside Square redevelopment project has reached significant milestones this year, transforming from community vision to a completed development on East Main. This achievement is a testament to the collective efforts of our generous donors, dedicated staff, the Eastside Neighborhood Association, and the invaluable input from the community.

Eastside Square now includes six two-bedroom, mixed-income, affordable, and energy-efficient housing units, as well as 1,800 square feet of commercial space. Our partners, Lockett-Jones Realty and Dover Birch, collaborated with Land Bank staff and the real estate committee to prepare both the condominiums and commercial space for market launch. A key feature of this project is its affordability; the condominiums are available to individuals earning between 60% and 120% of the area median income. The real estate committee is committed to providing opportunities for homeownership within these affordability guidelines.

Looking forward to 2024, we anticipate welcoming new homeowners and businesses to Eastside Square. The completion of Building C represents a significant step in our ongoing commitment to revitalizing the East Main area.

Riverview Launch

The grounds feature beautiful drought-tolerant gardens, native plantings, and butterfly gardens, all offering stunning views of the river. As more visitors come to Riverview Launch, the Land Bank is committed to enhancing the beauty of this area. Our staff truly enjoy the access to the River Valley Trail and the scenic surroundings. Barn Redesign

In 2023, Riverview Launch faced some challenges, including several break-ins at the barn over the summer, which impacted our tenant, Open Roads. We worked swiftly to repair the extensive damage to the windows and doors to ensure that Open Roads would not be affected any further. While the barn looks bit different, the redesign of the barn at the rear of Riverview Launch ensures that our tenants are protected and Riverview Launch remain a safe space for our staff, tenants, and visitors.

In 2023, we were excited to resume rentals of Riverview Launch's indoor facilities, hosting several nonprofit organizations throughout the year.

Our indoor space features a large conference room and a hub with a kitchen that opens up to create a seamless indoor/outdoor gathering area. Thanks to our dedicated contractors and staff, guests can fully enjoy the beauty of the facility

Open Roads Bike Program





Open Roads Bike Program is working harder than ever in 2023! Open Roads partnered with several refugee serving organizations to provide bicycles for newly settled refugees. They donated 123 bikes to this cause – and plan to donate even more in 2024. Open Roads is also supporting the work of Dignity in Motion, a non-profit dedicated to serving unhoused community members. The Open Roads team is excited to see four youth apprentices graduate High School and move onto the next stage in their lives -- we thank these seniors for working with us during their high school career. Open Roads is a proud supporter of after-school learning and is excited to be a partner among many in the Kalamazoo non-profit landscape.

Kalamazoo River Watershed Council

The Kalamazoo River Watershed Council has been busy in the past year. providing a public voice and information source for the ongoing cleanup of the Kalamazoo River, and for connecting people with this outstanding natural resource and our part of Southwest Michigan. The KRWC provides the leadership our region needs to help bring the Kalamazoo River back into the lives of residents and visitors to southwest Michigan as a place for clean, nature-based outdoor experiences that we all need for our personal and community wellbeing and quality of life. In the past year, the KRWC has worked with federal and state agencies to provide input to the planning and progress being made to clean up the Kalamazoo River's past PCB contamination, and communicate that progress to the public. Implemented the State of Michigan Department of Health and Human Services' River Walker program to communicate information about the "Eat Safe Fish" guidelines to Kalamazoo River anglers and their families. Worked with several partners to organize half-day paddle trips on many parts of the river, from Albion to Kalamazoo to New Richmond so more people can enjoy the Kalamazoo River. Helped underserved youth in Kalamazoo and other communities learn about and experience the Kalamazoo River, reducing inequities to safely accessing the life-long benefits of the Kalamazoo River as a natural resource.

This past year, our office location at Riverview Launch gave us a firsthand view of some of the cleanup projects that are being implemented in the Kalamazoo River today. The sights and sounds serve as a reminder of the importance of our mission and our focus on collaborating with communities, government agencies, local officials, and businesses in the Kalamazoo River Watershed to restore and protect the Kalamazoo River for all.

Vibrant Kalamazoo

Engaging and Connecting Community

Vibrant Kalamazoo, a 501 (c)3 supporting organization, is the community engagement and fundraising arm of the Kalamazoo County Land Bank. In 2023, Vibrant continued to engage with Land Bank board members, staff, nonprofit leaders through the Affirmative Marketing Campaign. The Affirmative Marketing Campaign's goal is to increase homeownership of low-income residents, people of color, and non-English speakers.
